# WEB 1005 Best Practices in representing asylum claimants including victims of trafficking in Northern Ireland - spaces available

This one-day course looks at the law, processes and skills involved in representing asylum seekers in Northern Ireland. It will cover the asylum process from the point of claim through to the appeal hearing and grant of leave. # WEB 1002 Tier 4 and Study Routes

Navigating the Tier 4 visa routes can present a number of challenges to those practitioners who are either unfamiliar with the UK education system or who have relatively few clients applying under this part of the Immigration Rules. This training provides an overview of the Tier 4 route, taking into account both express and nuanced requirements that are placed on both the visa applicant and the Tier 4 sponsor. This session is delivered by former international student immigration advisers at a large Russell Group university and will seek to demystify the more complex aspects of the Tier 4 general policy. This course will provide practical examples to assist practitioners in having a better understanding of the study immigration routes and to support in their delivery of comprehensive, holistic advice to clients.

#### WEB 1028 Mergers and Acquisitions - Just announced

# Wednesday 13 May 2020, 15:00 - 18:15, 3.0 CPD Hours Tutors: James Perrott and Julian Grant, Macfarlanes

With the recent increase in merger, acquisition and restructuring activity in the UK, practitioners are more frequently being asked to advise on the immigration and right to work aspects of corporate transactions. Where one or more of the entities involved has a sponsor licence, this will often consist of reviewing the current sponsor licence arrangements, advising on the appropriate arrangement post-transaction and then taking the necessary steps to ensure that the appropriate entity is able to continue to employ its sponsored workers. This may involve either making a notification to the Home Office or submitting an application for a new licence. If the transaction involves staff transferring between entities, this can also involve right to work issues.

Depending on the complexity of the transaction, practitioners are often required to have a good working knowledge of corporate structures as well as employment law issues. Practitioners are also frequently required to have an understanding of the types of structures that international companies employ and advise on whether these structures mean that these businesses can

transfer their non-EEA overseas employees to the UK under the Tier 2 (Intra Company Transfer) category. The course will concentrate on the issues which affect Tier 2 sponsor licence holders, although some reference will be made to where the Tier 2 requirements differ from those that apply to Tier 4.

# WEB 1003 Applications and appeals under paragraph 276ADE(1) (iv) of the Immigration Rules ('7 Year Applications')

# Thursday 14 May 2020, 14:00 - 18:15, 4.0 CPD Hours Tutors: Lucy Mair, Garden Court North Chambers and Sumita Gupta, Islington Law Centre

This course is a practical guide to preparing successful applications for leave to remain for children (and their families) who have lived in the UK for 7 years or more, and challenging negative decisions on these applications. The course will provide an overview of law and practice in relation to these applications, and will also address fee waivers and No Recourse to Public Funds conditions and their relevance in applications. The course will also address the benefits of taking a Child Rights based approach to evidence and legal argument when preparing applications and appeals.

# WEB 1016 Nationality Law is Fun

The session is aimed at practitioners who want to develop their understanding of British nationality law and who are interested in more than making applications for citizenship. It complements the ILPA courses on naturalisation and registration of children. It covers automatic acquisition of British citizenship by birth or descent, tracing family status and old Commonwealth cases on and after independence, other forms of British nationality (e.g. British Overseas citizens), and dual nationality issues in practice. It also looks at the swing to correct historical injustices based on sex discrimination, illegitimacy and birth in the British overseas territories.

It considers the nationality legislation of 1914 and 1948 before turning to the development of the British Nationality Act 1981 and its revisions down to the present day. Understand the implications of status tracing for your client and emerge a better-informed and wiser immigration, asylum and nationality lawyer.

# WEB 1009 Appeal Rights and Administrative Review
