Notes to table

- 1. The table is a simplified presentation; the effect of the many complexities omitted on the fees they are minimal.
- 2. Legal Help (advice and assistance but not appeals) is the largest volume of work.
- 3. Appeals to the First Tier and Upper Tier Tribunal are carried out under Controlled Legal Representation ("CLR"). This mirrors the Legal Help scheme but with very slightly higher hourly rates for the main work.
- 4. Legal Help and CLR are collectively called "Controlled Work"; the number of cases being controlled by the Legal Services Commission.
- 5. Most Controlled Work cases are funded under fixed fees in the Graduated Fee Scheme.
- 6. If the value of the work (calculated at nominal rates for different work) exceeds three times the fixed fee payable then the case will be paid at an hourly rate (this is in essence the criterion but the exact calculation is more complex).
- 7. Claims can only be submitted once that part of the case is concluded (after UK Border Agency initial decision then after substantive appeal or earlier conclusion) and for the fixed fees initially.
- 8. The additional fees payable because the claim has become exceptional are only paid after a claim has been submitted to the Legal Services Commission and the file assessed and accepted by it.

- 9. The fixed fees and the nominal rates were increased by 2% for Legal Help and 5% for CLR appeals in 2007 for cases started on or after 1 July 2007 as a result of the litigation between the Law Society and the Commission. The rate for new cases only is quoted in the table for simplicity.
- 10. A smaller proportion of cases are still funded at hourly rates. These are generally older cases (commenced pre- 1 October 2007) and certain other categories of cases such as those for unaccompanied asylum seeking children or for suppliers holding a separate contract for Detained Fast Track asylum cases. The rates have been unchanged since 2 April 2001.
- 11. Appeals to the Upper Tribunal are funded within CLR. They are "at risk". No fees are payable if permission is refused. If permission is granted funding is at approximately 35% above the standard CLR rates for hourly paid cases.
- 12. There are different national fixed fees for asylum and immigration. For hourly paid work there is a London rate which is slightly higher than for outside London.
- 13. Work in the higher courts is funded at hourly rates under funding certificates. Very High Cost Cases are subject to individual contracts at generally lower hourly rates but constitute only a very small proportion of work so are not dealt with here.
