Home Office ten-point plan

On 14 January, the Immigration Minister, Liam Byrne MP, gave a speech to staff of the Border and Immigration Agency (BIA). In that speech, he set out a ten-point plan for the coming year giving dates by which changes would be achieved. Review of citizenship

Lord Goldsmith QC, the former Attorney General, is conducting a review about British citizenship. He is to report to the Prime Minister in March. Meanwhile his review is open for individuals or organisations to offer their views. Details about the review are available from the information sheet on "Citizenship Review".

Visitors to the UK

In December, the BIA issued a consultation paper concerning visitors to the UK. The proposals under consideration may affect tourists, business visitors and those visiting family and friends.

UASC reform programme

Those who work with unaccompanied asylum-seeking children (UASC) will have been waiting for further information from the BIA following the consultation on UASC reform that was issued in February 2007. This has recently been again delayed.

Criminal Justice and Immigration Bill

This Bill passed through the House of Commons with a plethora of additions, but these additions do not relate to immigration. The Bill contains provisions for a special immigration status (see previous Immigration Updates), and is now in the House of Lords.

Before Xmas, the Case Resolution Directorate allocated 310,000 cases to around 60 new teams. The allocation of a case to a team does not mean the case is now being actively considered. However, the establishment of these new teams means that legacy cases are likely to be considered at a faster rate than previously.
